For scheduling reasons, this particular regulation applies the 2025 regulations.

Regulation 2026 not being ratified and disseminated at the time of its drafting and validation.

Depending on the 2026 regulations, the organization may use an addendum to comply with them.

The support teams will be required to CLEAN THE AREA OF ALL TRACES OF MUD left after each intervention on the competition cars.

ONLY ONE assistance vehicle per competition car will be allowed in the assistance parks, with a "ASSISTANCE" sticker affixed to the top right of the windscreen.

**A penalty of €200 will be applied** by the sports commissioners for each violation found in article 4.3.P.

The penalties are cumulative. The amount of the penalty is retained by the organizer.

## ARTICLE 5P. ADVERTISEMENT

### 5.1P. VEHICLE IDENTIFICATION

*Compliant with standard rally regulations and the French off-road rally championship.*

### 5.2P. ADVERTISING

Mandatory or optional advertising will be communicated by an addendum to these specific regulations.

The mandatory AGORA TT advertising must be affixed to the FFSA location on the front plate of the vehicles and be visible, in accordance with article 5.2 of the French All-Terrain Rally Championship, under penalty of the sanctions provided for in article 5.2.4 of the standard rally regulations: a penalty of €160 for the first offence and a penalty of €320 in the event of a repeat offence.

## ARTICLE 6P. SITES AND INFRASTRUCTURE

### 6.1P. DESCRIPTION

The **43rd Arzacq and Soubestre Hills off-road rally** represents a **total route of 259.46 km**, including 159.81 km of liaison.

It is divided into **two stages** and **4 sections** and includes **12 special stages with a total length of 92.94 km** of special stages.

## **6.2P. ACKNOWLEDGMENTS**

*Compliant with the regulations of the French off-road rally championship.*

Competitors will be required to provide the registration numbers of the reconnaissance motorcycles and quads and wear the wristbands provided by the organization as well as the stickers on the reconnaissance motorcycles/quads.

Otherwise, they will be prohibited from starting reconnaissance runs, and the penalties provided for in article 6.2 of the FFSA standard rally regulations will apply.

### **6.2.6P. DATES AND TIMES OF RECONNAISSANCES**

The reconnaissance missions will take place:

**March 5, 2026, from 8:00 AM to 6:00 PM**

**March 6, 2026, from 8:00 AM to 4:00 PM**

A reconnaissance logbook, used to record the 3 authorized passages, will be given to the competitors. They must present it to the officials.

Refusal to submit to a check will be penalized with a 1-minute penalty during the first stage.

They will have to be done at reduced speed, as the roads are open to all traffic.

It is forbidden to carry out reconnaissance against the flow of traffic.

**A reconnaissance convoy will be conducted if weather conditions permit.**

**March 6, 2026 at 8:00 AM.**

Departure from Place Marcadieu, Arzacq-Arraziguet. Tires

suitable for the weather conditions are mandatory.

## **ARTICLE 7P. PROGRESS OF THE RALLY**

*Compliant with standard rally regulations and specific off-road rally rules*

### **7.5.17.1P ABANDONMENTS**

## 7.5.17.3P RACE ROAD

Competitors are advised that the inside edges of corners and changes of direction, as well as the outside edges of chicanes, will be protected and marked to prevent crossing the racecourse boundaries. Any contact with or crossing of these markings will be considered a violation of the racecourse rules.

## 7.6P GATED PARK

In accordance with article 7.6 of the specific rules for off-road rallies, vehicles without a watertight door (net) or SSV vehicles are allowed to put a tarpaulin on the car/vehicle to protect it from possible bad weather.

These vehicles in groups T1A and T1B must meet the following criteria:

- Chassis built 20 years ago or more (date of creation of the technical passport) - Year of origin of the engine "manufacturer" reference before 2001 - H-pattern or sequential gearbox depending on the vehicle's original equipment - Overhanging or mid-mounted engine depending on the original layout - Free-moving shock absorbers

The competitor must specify their application in this category on the entry form, committing to comply with the technical requirements, which may be verified by the organizer.

- 2 trophies for the top 3 teams in the French Championship (T1A/T3 combined)
- 2 trophies for the top 3 in the 4X4 Trophy (T2, T2B and T2B+ combined)
